This award is based primarily on sales volume with additional emphasis on interaction with other agents, participation in the Cache Valley Association of Realtors® and community involvement.

### AWARD ELIGIBILITY

Agent must have an active sales agent license for the award year and is eligible for the award up until the Agents first license renewal (two years from license issue date). Agent must have completed a minimum of **ten (10) transactions** in the award year (November 1, 2020 through October 31, 2021). Previous recipients of the award are no longer eligible, even if within their first license renewal.
